1. Admission to the enhanced 40(forty) seats is subject to approval by respective regulatory Council.
2. All admission to the course(s) shall have to be made only through Entrance Examination conducted by Srimanta Sankaradeva University of Health Sciences as per the Assam Gazette Notification No.MER.206054/786, dated 07-11-2023 and follow the norms as per Notification No.MER.197726/96, dated 28-06-2024 regarding Training Institute.
3. The minimum qualification for selection of the candidates will be as per criteria laid down by Indian Nursing Council/ State Nursing Council.
4. The college will be designated as Examination Centre by the University only if the College has minimum 50% students of total intake capacity permitted by SSUHS/ Council and the College is approved as Examination Centre by the University. Otherwise examination of students will be conducted at other designated Examination Centre which shall be notified by Srimanta Sankaradeva University of Health Sciences in due course of time.
5. This affiliation is for Academic Session 2025-26 upto 31-07-2026.
6. Application for renewal of affiliation must be submitted by the Institute before 30-06-2026.
